



# Warranty Terms and Conditions

## LS & LP Compressors

Atlas Copco warrants to the end user that the above mentioned Atlas Copco stationary cast iron reciprocating compressor shall be free of defects in design, material and workmanship for a period of fifteen (15) months from date of shipment to purchaser, or twelve (12) months from date of initial start-up, whichever occurs first. The above offer applies except as set forth in Warranty Scope & Limitations. Failure to meet the Warranty Scope & Limitations invalidates this program.

### Original Component Warranty: New Compressor Pump Installed in a Registered LS/LP Cast Iron Reciprocating Compressor

Atlas Copco warrants to the end user that the factory installed compressor pump for the above mentioned Atlas Copco Reciprocating Compressor shall be free of defects in design, material and workmanship for a period of sixty-three (63) months from date of shipment to purchaser, or sixty (60) months from date of initial start-up, whichever occurs first. The Compressor Pumps rings and gaskets are covered for the entire period. Suction and discharge valves are covered for the entire sixty (60) to sixty-three (63) month period provided the valves are replaced every twenty-four (24) months. Provided the customer has met the specified Extended Coverage Terms & Conditions, the above offer applies except as set forth in Warranty Scope & Limitations. Failure to meet the Extended Coverage Terms & Conditions invalidates this program.

Provided the customer has met the specified Extended Coverage Terms & Conditions, the above offer applies except as set forth in Warranty Scope & Limitations. Failure to meet the Extended Coverage Terms & Conditions invalidates this program.

Atlas Copco warrants to the end user that the purchased oil-free compression element for the above mentioned Atlas Copco stationary oil-free compressor shall be free of defects in design, material and workmanship for a period of twenty seven (27) months from date of shipment to purchaser, or twenty four (24) months from date of initial start-up, whichever occurs first. Provided the customer has met the specified Extended Coverage Terms & Conditions, the above offer applies except as set forth in Warranty Scope & Limitations. Failure to meet the Extended Coverage Terms & Conditions invalidates this program. New element installed by Atlas Copco or Atlas Copco authorized distributor.

### **Replacement Element Extended Warranty: Exchange Element Warranty Installed in Registered Oil-Flooded GA/GX**

Atlas Copco warrants to the end user that the purchased oil-flooded compression screw element for the above mentioned Atlas Copco stationary oil-flooded compressor shall be free of defects in design, material and workmanship for a period of twenty seven (27) months from date of shipment to purchaser, or twenty four (24) months from date of element replacement and respective equipment start-up, whichever occurs first. Provided the customer has met the specified Extended Coverage Terms & Conditions, the above offer applies except as set forth in Warranty Scope & Limitations. Failure to meet the Extended Coverage Terms & Conditions invalidates this program. New element installed by Atlas Copco or Atlas Copco authorized distributor.

### **Replacement MD Rotor Extended Warranty: Exchange Rotor Warranty Installed in Registered MD Dryer**

Atlas Copco warrants to the end user that the purchased MD rotor for the above mentioned Atlas Copco stationary dryer shall be free of defects in design, material and workmanship for a period of sixty-three (63) months from date of shipment to purchaser, or sixty (60) months from date of initial start-up, whichever occurs first. Provided the customer has met the specified Extended Coverage Terms & Conditions, the above offer applies except as set forth in Warranty Scope & Limitations. Failure to meet the Extended Coverage Terms & Conditions invalidates this program. New MD rotor installed by Atlas Copco or Atlas Copco Authorized distributor.

## Spare Parts - General

### Spare Parts Warranty: General Spares

Atlas Copco warrants to the end user that the purchase of general spare parts shall be free of defects in design, material and workmanship for a period of ninety (90) days from date of shipment to purchaser, under the condition that the part has been subject to normal use and maintenance.

## OriginAir Warranty Refurbished Elements

Atlas Copco warrants to the end user that all genuine compressor elements manufactured by Atlas Copco and affiliates shall be free of defects in design, material and workmanship for a period of twenty seven (27) months from date of shipment to purchaser, or twenty four (24) months from date of element replacement and equipment start-up, whichever occurs first.

## Extended Coverage Terms & Conditions

1. The machine's Extended Warranty Registration Form must be submitted within thirty (30) days of start-up.
2. The equipment must be properly installed in accordance with the Atlas Copco installation proposal and instruction manuals.
3. Equipment start-up must be performed by an Atlas Copco representative or an Authorized Atlas Copco Distributor. Start-up Exceptions on compressors: Customer, Atlas Copco, or Authorized Atlas Copco Distributor can perform start-up on GX and GA Fixed Speed Oil Injected Rotary Screw Compressors up to 15KW and on LS/LP, LE/LT/LF, & AR/KT reciprocating compressors. Start-up Exceptions on quality air products: Customer, Atlas Copco, or Authorized Atlas Copco Distributor can perform start-up on FD5-220 single phase dryers, FX1 to FX21 dryers, CD+1-22 dryers, SD dryers, inline compressed air filter assemblies, and ConservAir. On units where a customer does the start-up themselves any damage to equipment during start-up is not covered by the warranty.
4. A start-up report, properly completed by an authorized Atlas Copco representative, must be submitted to Atlas Copco Compressors within 30 days of start-up.
5. Only genuine Atlas Copco spare parts and lubricants may be used in the equipment.
6. The equipment must be maintained in accordance with the published Atlas Copco service schedules for the duration of the extended warranty period.
7. For all machines larger than 30KW, except vacuum machines, service must be performed by Atlas Copco, an authorized distributor, or an approved customer technician. For all vacuum machines service must be performed by Atlas Copco or an authorized distributor technician.
8. Compressors: The service provider must participate in the oil analysis program and submit an oil sample for oil analysis a minimum of once per year for equipment operating 4,000 hours or below and twice per year for units operation above 4,000 hours. Vacuum: end users or distributors of vacuum pumps must participate in the oil analysis program and submit an oil sample for analysis on a regular basis as outlined in the instruction book. Oil sample frequency is dependent on product type and application. For harsh environments more frequent oil sampling is required. In no situation will the oil sample period be less than 500 hours.
9. All machines larger than 30KW, except vacuum units, must be under a parts only service contract as a minimum, either through Atlas Copco or an authorized distributor.
10. All claims have to be filed in a timely manner, 30 days is considered normal.
11. The service provider must keep records of all spare parts purchases for machines not on contract, as well as scheduled maintenance, and oil analyses. The following records will be required for any claim within the specified Extended Warranty Period:
  - \*Copy of an Extended Warranty Registration Form
  - \* Copy of start-up report
  - \*Copies of all maintenance records for the equipment
  - \*Proof of purchase of genuine Atlas Copco spare parts and lubricants if not on contract
  - \*Copies of all oil analysis reports.

## Warranty Limitations

For Atlas Copco equipment eligible for and replaced under the agreed warranty, the new component (replacement part) warranty period is equal to that remaining on the item replaced. As an example, a defective cooler is replaced at 3 years on a GA compressor. The warranty remaining is 2 years. For any compressed air equipment in this product range not commissioned by an authorized Atlas Copco service provider, the product is sold AS IS and with no representation or warranty whatsoever. Warranty is excluded when the product is misused or neglected, which includes the ingestion of corrosive, erosive, or explosive liquids or gases. In addition, on vacuum machines problems caused by customer process failures or upsets and inadequate inlet protection are excluded from the warranty. Should any failure to conform with this warranty appear prior to or after shipment of the product to the customer during the specified periods under normal and proper use and provided the product has been properly stored, installed and maintained by the customer. Atlas Copco shall, if given prompt notice by the authorized selling agent, repair or replace, F.O.B. Atlas Copco warehouse, the non-conforming product or authorize repair or replacement by the service provider. Replaced products and parts become the property of Atlas Copco.

## Warranty Scope

The Atlas Copco warranty does not extend to products not manufactured by Atlas Copco or affiliates. As to such products, the selling agent shall be entitled to proceed only upon the terms of that particular manufacturer's warranty. The Atlas Copco warranty does not apply to defects in material provided by the selling agent to design stipulated by the selling agent. Any services performed by Atlas Copco in connection with the sale, installation, servicing or repair of a product are warranted to be performed in a workmanlike manner. If any nonconformity with this warranty appears within thirty (30) days after the services are performed, the exclusive obligation of Atlas Copco shall be to re-perform the services in a conforming manner.
